All tests are delivered in Kite® Student Portal (except HGSS) and include multiple-choice and technology-enhanced items. KELPA speaking and writing assessments are human scored. All other assessments are machine-scored. Interim and 2nd grade assessments are optional. General summative, Kansas English Language Proficiency Assessment (KELPA), History, Government, and Social Studies (HGSS), and Dynamic Learning Maps® (DLM®) assessments are mandatory.
