How will the SEA ensure that each LEA not excepted is maintaining equity in High Poverty Schools?

KSDE provides guidance and technical assistance to school districts on the LEA Maintenance of Equity requirement and process. KSDE utilizes finalized state and local expenditure data, district enrollment data, and building directory information to determine which LEAs are eligible for exemption from the MOEquity requirement. Eligible LEAs may submit Appendix B LEA Certification of Exception from Local Maintenance of Equity Requirements to too request an exemption due to exceptional or uncontrollable circumstances. During the distirct budgeting process, if the aggregate State and Local per pupil revenue will decrease, the LEA should determine if Fiscal Equity and Staffing Equity will be maintained in High Poverty Schools in the LEA.
