# Kansas State Performance Plan: Indicator 68 Preschool Environments

#### What is Indicator 6?

Indicator 6 measures the Early Childhood Least Restrictive Environments (EC LRE)

#### **Regulatory Requirement**

To the maximum extent appropriate, children with disabilities must be educated with children who are not disabled. 20 U.S.C. § 1412(a)(5)(A); 34 CFR § 300.114(a). Each IEP must include an explanation of extent, if any, to which a child will not participate with nondisabled children. 20 U.S.C. § 1414(d)(1)(A)(i)(V); 34 CFR § 300.320(a)(5). Each local education agency must make a continuum of alternative placements available. 20 U.S.C. § 1412(a)(5); 34 CFR § 300.115.

### Indicator 6 is divided into three categories

Indicator 6A measures the percent of children ages 3 through 5 with IEPs attending a regular early childhood program and receiving the majority of special education and related services in the regular early childhood program.

**Indicator 6B** measures the percent of children ages 3 through 5 with IEPs attending a separate special education class, separate school or residential facility.

**Indicator 6C** category measures the percent of children ages 3 through 5 with IEPs receiving special education and related services in the home setting.
