Policy statement regarding 2021 state assessment expectations:

The Kansas State Department of Education expects all students in assessed grades to take state assessments. This expectation includes students enrolled in virtual programs or schools, and those in remote learning environments. This policy applies to the general assessments, KELPA, and DLM. No assessment may be given remotely. The general assessment window for English language arts, math, and science opens on April 1 and closes on May 18, 2021. KSDE staff are available to assist districts in exploring options for proctoring locations. Federal CARES Act ESSER funds may be used to make sure all students have the opportunity to test in a safe environment. If a student is still unable to test, please use (SC) special circumstances code 19 to identify remote students unable to take state assessments

Agile Technology Solutions (ATS)

Agile Technology Solutions (ATS) has added a new feature this year to KITE that provides a parent access to their child's KS Assessment score reports through a new, secure website called Kite Parent Portal! Kite Parent Portal allows parents to access their child's score reports from all Kansas Assessment Program (KAP) tests including Interim, Summative, DLM, and KELPA. Districts will set up login information for parents to allow access. For more information ask your District Test Coordinator.

Benefits of WorkKeys and NCRC Certificates

The Kansas Legislature appropriated funds for a statewide contract to provide one free ACT assessment and one free WorkKeys suite of assessments to all public high school juniors. Students are encouraged to take both assessments. Click <u>here</u> for more information.

Funding Opportunities for the 2021-2022 School Year

We are pleased to share that the 2021-2022 Preschool-Aged At-Risk program approval form, Kansas Parents as Teachers grant renewal application and Kansas Preschool Pilot Request for Proposals (grant application) are now posted to **the KSDE Early Childhood webpage:**



- Kansas Preschool Pilot (KPP) Grant Request for Proposals: This document details requirements and directions for applying for the grant. This year's application will be entered into the Kansas CommonApp system. Applications are due by 11:59 p.m. on February 9, 2021.
 - Kansas Preschool Pilot grant funds should build on existing sources of state and federal funding, such as state school finance formula funds and special education funds. The Kansas Preschool Pilot grant application and award process looks quite different for 2021-2022. Rather than funding most applicants at a percentage of their initial funding request, a more competitive process will award funding based on the need and merit demonstrated in the program application.
- Preschool-Aged At-Risk Program Approval Form: Districts will complete this form in a Qualtrics survey. Approval forms must be submitted by 5:00 p.m. on April 2, 2021 in order to be approved by the Kansas State Board of Education in May.
 - Kansas Preschool Pilot grant funds should build on existing sources of state and federal funding, such as state school finance formula funds and special education funds. The Kansas Preschool Pilot grant application and award process looks quite different for 2021-2022. Rather than funding most applicants at a percentage of their initial funding request, a more competitive process will award funding based on the need and merit demonstrated in the program application.
- Kansas Parents as Teachers (KPAT) Grant Renewal application: This document details requirements and directions for applying for the grant. This year's application will be entered into the Kansas CommonApp system. Applications are due by 11:59 p.m. on April 2, 2021.
- The Kansas CommonApp portal is a new grant submission tool to manage applicant profiles and proposals across a variety of state agency funding opportunities. View the Kansas CommonApp Technical Assistance Webinar for training on how to use the CommonApp system.

CARES/ESSER

The Coronavirus Aid, Relief, and Economic Security (CARES) Act was enacted on March 27, 2020, and included Elementary and Secondary School Emergency Relief (ESSER) Funds for K-12 schools. These ESSER grants will provide school districts with emergency relief funds to address the impact COVID-19 has had elementary and secondary schools. To access the CARES/ESSER Fact Sheet, click here. Mentor Kansas, a program of the Kansas State Department of Education, has released the Elements of Effective Practice for Mentoring mini-grant opportunity. This grant will fund mentoring initiatives that implement one or more of the Elements of Effective Practice for Mentoring. Mentor Kansas will make available up to \$25,000 in grants and expects to award grants between \$1,500 – \$2,500 per eligible entities.

Eligible entities include public or private nonprofit organizations, including faith-based and other community organizations; school districts, institutions of higher education; government entities within states or territories (e.g., cities, counties); labor organizations; partnerships and consortia; and Indian Tribes. The application deadline is February 22, 2021.
