## C to B Transitions (Indicator 12)

# Indicator 12: C to B Transitions

- Smooth, seamless transitions from Part C to Part B ensure young children with disabilities receive services without disruption or delay.
- Part B Indicator 12 is a compliance indicator that measures the percent of children referred by Part C prior to age 3, who are found eligible for Part B, and who have an IEP developed and implemented by their third birthdays.
  - <u>20 U.S.C. §1416(a)(3)(B)</u> and <u>34 C.F.R. §300.101(b)</u>.

## Part C to Part B Electronic Referral System (CBER)

- Every agency should be regularly logging into CBER (<u>ksits.kdhe.ks.gov</u>) to review and accept referrals.
  - Ensure you've designated a person responsible and have this on the calendar.
  - The CBER system will help you plan and prepare for smooth transitions from Part C to Part B.
- The Office of Special Education Programs (OSEP) requires KSDE to maintain a statewide system that tracks children who are transitioning from Part C to Part B. CBER allows for confirmation of the accuracy of referral dates reported by both C and B programs.

- The transition timeline for a referral begins on the date it is sent by Part C unless the referral is actively rejected by Part B.



# Indicator 12: C to B Transitions

- Make plans for students turning three years old this summer.
  - Who will be checking CBER and accepting referrals?
  - Who will be completing evaluations?
  - What's the process when a child transitioning from Part C to Part B moves into the district during the summer months?
- This is a good time to be referring to your local Memorandum of Understanding (MOU) between Part C and Part B.
  - Are there items that you might address the next time you update this MOU?
  - KSDE and KDHE are glad to assist in facilitating local reviews and updates.

## Topics from recent trainings that KSDE and KDHE will address in future guidance

- Children transitioning from Part C to Part B should not be screened prior to beginning an evaluation.
- How best to invite the Part C Family Service Provider to the initial IEP meeting.
- A classroom of preschool students who are 3 years old on or before August 31 is a component of a continuum of placement options available for children turning 3 years old during the school year.
- Districts may require that families enroll children during the transition process. However, if a family does not complete this enrollment step, it does not change the district's responsibility to have an IEP developed and implemented by the child's third birthday.
- Role of 504 plans or other appropriate services for children referred from Part C who are determined ineligible for Part B services.

# Districts should provide the most inclusive classrooms possible.

The Individuals with Disabilities Education Act (IDEA) requires that to the maximum extent appropriate, children with disabilities, including children in public or private institutions or other care facilities, are educated with children who are not disabled, and special classes, separate schooling, or other removal of children with disabilities from the regular educational environment occurs **only** when the nature or severity of the disability of a child is such that education in regular classes with the use of supplementary aids and services cannot be achieved satisfactorily.

Research shows that early childhood inclusion is beneficial both to children with and without disabilities. The beginning years of all children's lives are critical for building the early foundations of learning and wellness needed for success in school and later in life... High-quality inclusion that begins early and continues into school likely produces the strongest outcomes.

## Indicator 6: Preschool Environments

- This data point measures the extent to which preschool students with IEPs receive the majority of their special education and related services in the least restrictive environment.
- <u>Review the 2024-2025 Projected Indicator 6 Report in the KSDE SPEDPro</u> <u>authenticated application</u>.
  - Districts that received Kansas Preschool Pilot grant funds identified action steps to improve if they are not currently meeting state targets.
  - Districts must meet state targets for Indicators 6A and 6B for 2024-2025 to be eligible to apply for Kansans Can Star Recognition for Kindergarten Readiness.

# Indicator 7: Early Childhood Outcomes

- Indicator 7 measures the percent of preschool children aged 3 through 5 with an individualized education program (IEP) who demonstrate improved:
  - Positive social-emotional skills (including social relationships);
  - Acquisition and use of knowledge and skills (including early language/communication and early literacy); and
  - Use of appropriate behaviors to meet their needs.

## 2024 Post School Outcomes Timeline

## April 15 to May 31: Student Data Verification

Watch for email from DDE with login info prior to April 15, 2024. Be sure to verify all contact info using your Student Exit Surveys in the Post School Outcomes Web application, then verify with local IEP system and SIS. Once contact data for each exiter is provided districts need to make calls to verify that the contact info is correct. This is your opportunity to communicate with parents/students that they will be hearing from you (if you opt in) or from the call center acting on behalf of KSDE. Opt in deadline is May 31, 2025.

## June 1 through June 30: Prep for July Interviews

Emails/Text Messages to all exiter contacts go out June 9 - 13, For Opt in Districts: Final Call lists sent to districts week of June 24. KSDE Sped Leadership Conference: June 25 – 27: Watch for Transition Breakout Sessions June 24 training webinar for opt in district interviewers available.

## July 1 through July 31: Call window is open.

Exiter interviews completed by July 31, 2024.

## Deadlines

The remaining payments pay on ONLY **ELIGIBLE** FTE!

- April 1<sup>st</sup> Final day to enter/update before fourth payment
- April 15<sup>th</sup> Final day to enter/update Vacancy report for special education staff
- May 1<sup>st</sup> Final day to enter/update staff and positions for the year.
- June 2<sup>nd</sup> Final day to enter/update inservice

# Ask for Help!

- Error: No Eligible FTE due to missing qualifications-NO FUNDING
  Discrepancy: Partial Eligible FTE due to qualification dates-PARTIAL FUNDING

- If there are questions about why someone is an error (after reading the actual error and checking licensure), or why someone is a discrepancy (after checking their licensure), CONTACT ME! I am available by email (preferred), and phone (might be busy or I might be offsite).
- It is too late in the year to maximize reimbursement, but I can still help your district get the most reimbursement possible.

It's not "bothering" me, it's "justifying my employment"!

Not a test – There's no penalty for asking questions!

There is still a lot of "fixable" FTE

## Don't wait until the final week

There were hundreds of new positions/assignments added Friday and Monday before the 3<sup>rd</sup> payment. I can't run the statewide report when the system is overwhelmed, so my ability to answer questions about the new stuff was limited.

## Email questions:

Include information

(copying the row from the payment report is excellent or sending a screenshot of program problems)

#### The words of an error are important.

"We have a teacher ..." is less useful than "Fred Smith ID 1234567890"

#### Subject line

"D0100 question about Fred Smith error" is harder to miss than "help", "pca question" or just replying to a listserv message

## Substitutes

If the substitute is not approved, one of these things is a problem

- Wrong ID is being used or person has no license for substituting
- Position is literally called "substitute"
- Position isn't filled
  - Substitutes must be claimed in the same position as the teacher they are replacing
  - Just need a statement that the position was unfilled before or after
  - Missing dates affect para reimbursement

## Vacancy Report

Different from the report for Teacher Licensure

- **TLA vacancy definition**: *any KSDE-licensed position not filled or filled by an individual who isn't licensed for the assignment (not licensed, expired license, sub license, licensed unqualified).*
- PCA vacancy definition: Is your LEA looking for someone else to fill the position?
- **Only** place to report how many non-KSDE licensed staff and paras are needed.
- Important to list the KSDE licensed staff as well
  - Teacher Licensure report is based on qualification, ours is how many people you are needing to hire.

# Individual Corrective Action (ICAs)

- An ICA must be completed for every student on every question that was non-compliant
  - Exception student has graduated or is no longer in the district
  - Click delete and select the reason
- ICAs are completed in KIAS
- ICAs are due by April 1
- ICAs must contain:
  - Statement of actions taken to correct the individual child specific noncompliance
  - Location of the documentation of actions taken to correct the child specific noncompliance
  - Date of correction by LEA
  - LEA contact information
  - Upload documentation showing file was corrected.

## **Updated Data**

- Updated data will pull IEPs that were completed between March 14 and May 14<sup>th</sup>.
  - KIAS does not have a way of identifying students who had an evaluation or reevaluation during those dates.
  - It is vital that districts are reviewing the evaluations for students with IEPs in this date range now to ensure they are compliant if they are selected.
- Districts will **answer yes/no and upload documentation** showing the file is compliant between May 15-May 29.
  - Districts are only responding on the questions that had non-compliance
  - If a district selects no or does not upload documentation showing compliance, they will have to go through another round of DCAPs, ICAs, and updated data.



## New 619 Questions Beginning with Cohort 2

24. This question only applies to early childhood 3-5. If this student is an early childhood student, did the student receive early intervention services (IFSP)? <u>34 CFR §303.13</u> If yes answer next 2 questions.

a. Was there LEA representation at the 90-day transition conference? [34 CFR <u>\$303.209</u>]

<u>K.A.R. 91-40-2(b)(3)</u> says: "If a child is transitioning from early intervention services provided under part C of the federal law, the agency responsible for providing FAPE to the child shall participate in transition planning conferences for the child."

There is also a federal Part B requirement in 34 C.F.R. §300.124(c) that says "Each affected LEA will participate in transition planning conferences arranged by the designated lead agency under section 635(a)(10) of the Act."

b. Did the IEP Team consider the child's transition plan when developing the child's initial Part B IEP? (K.S.A. 72-3428(b)(1))
