Director Updates

- Differentiated Monitoring System – SETS sent the Kansas Policies, Practices, and Procedures corrective actions to OSEP on October 8, 2025. We will wait until they reopen to hear back if what we have provided is sufficient to meet requirements.
- The SETS Team is collecting and analyzing data to include in the 2024 SPP-APR submission to OSEP on or before February 1, 2026.
- The Education Funding Task Force has permission to meet one more time to work on an RFP to review school district funding.
- There should be no interruption in federal funding for IDEA.



Director Updates (Con't)

- The KIAS Stakeholders will meet on October 14, 2025, at the Holiday Inn in Wichita. Each KASEA Region has been asked to send a representative to this meeting which will be led by Brian Dempsey, Assistant Director.
- The Special Education Quarterly #2 meeting will be held at the Holiday Inn in Wichita on October 15, 2025. ALL special education administrators are encouraged to attend.
- There is still time to register for the Tri-State Law Conference that will be held in Omaha, NB on November 13 and November 14.

Director Update (Con't)

- Cary Rogers has sent out new proposed targets for Indicators 3B (proficiency rate for children with IEPs against grade-level academic achievement standards) and 3D (gap in proficiency rates for children with IEPs and for all students against grade-level academic achievement standards). Interested stakeholders are invited to submit comments on or before November 10, 2025. Please submit written comments to SESPublicComments@ksde.gov or mail comments to Special Education and Title Services, Kansas State Department of Education, 900 SW Jackson Street, Suite 620, Topeka, Kansas 66612.
- A public hearing will be held at KSDE from 10 a.m. until 11 a.m. on October 30 and again on November 6 at KSDE from 10 a.m. until 11 a.m.
- The Office of Special Education Programs (OSEP) expects a state to revise baseline data when the state changes methodology or the data source for the indicator. Kansas has a new state assessment administered last year, so it must adjust the targets for Indicator 3.



Director Update (Con't)

- The Targeted Improvement Plan (TIP) has a due date for entry on or before October 15. Several agencies have NOT submitted a TIP application. Please contact Sarah Reed at sarah.reed@ksde.gov for assistance if your agency receives a reminder stating your agency has not submitted a TIP application.

Teacher Licensure-Waivers

- **Deadline for waivers** this semester is 11/1
 - Be sure the area and grades match what the person is doing and what is claimed (these **should** be the same thing).
 - Form 16-Accreditation Licensure Waiver is the application.
 - This includes Extension of Days waivers
 - Extension of days waivers are not available for staff with only limited / restricted licenses OR staff with “extended emergency substitute” licenses (the printed license says “Valid only for USD XXX”
 - Waiver questions go to TLALicense@ksde.gov (785) 296-2288



Substitutes



- Marking someone as a substitute hides all other errors/issues
 - If your substitute says “in process”-probably fine
 - “fine” doesn’t mean you are maximizing reimbursement!
 - If your substitute says “not approved”-there is a problem. Please ask me if you don’t know what the problem is.



Reimbursement Deadlines



Monday, December 1st is the final day to enter/update before the second payment.

- You have all day on the 1st, but at midnight the system locks

The second payment pays on ALL FTE that is claimed.

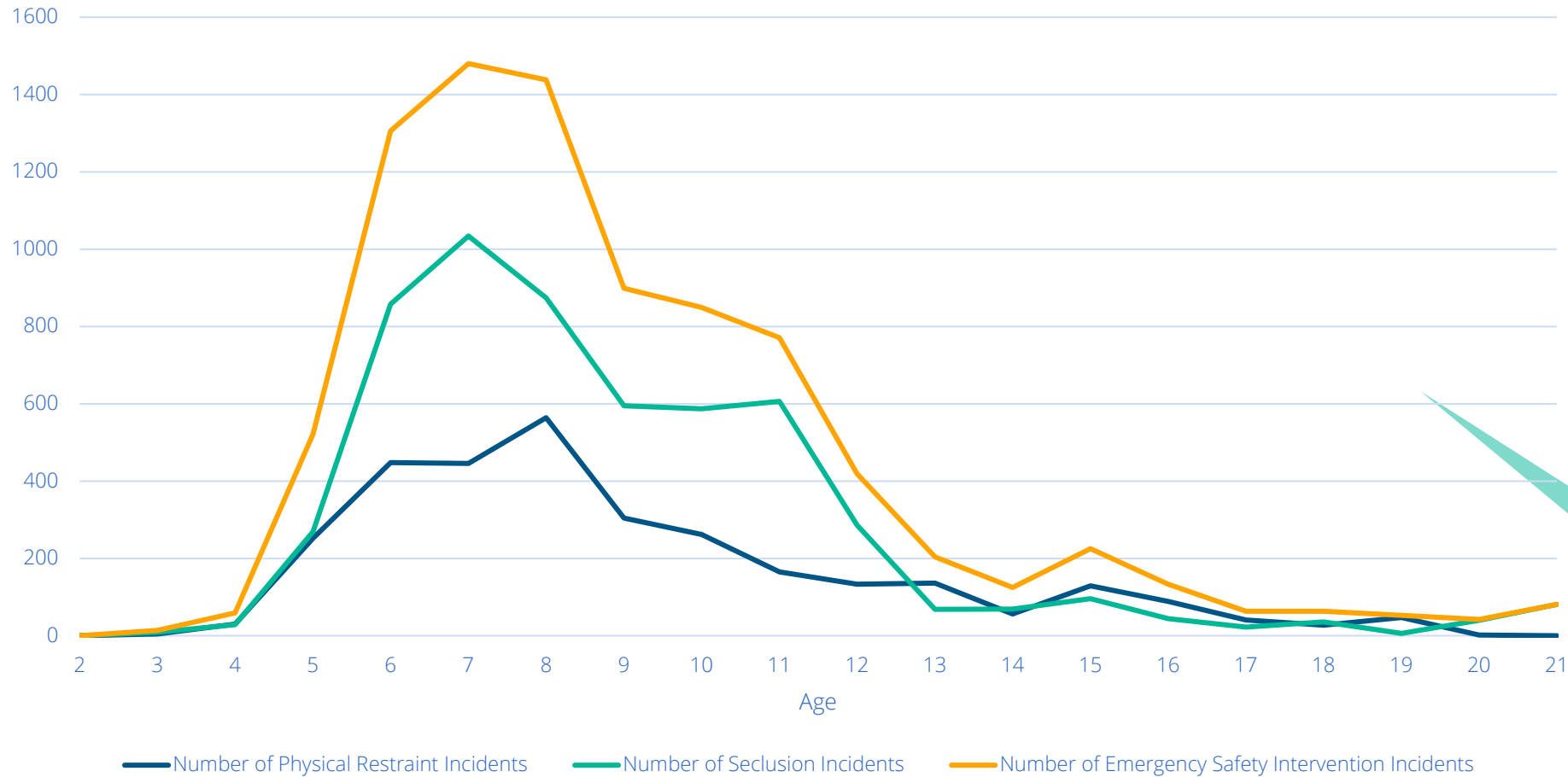

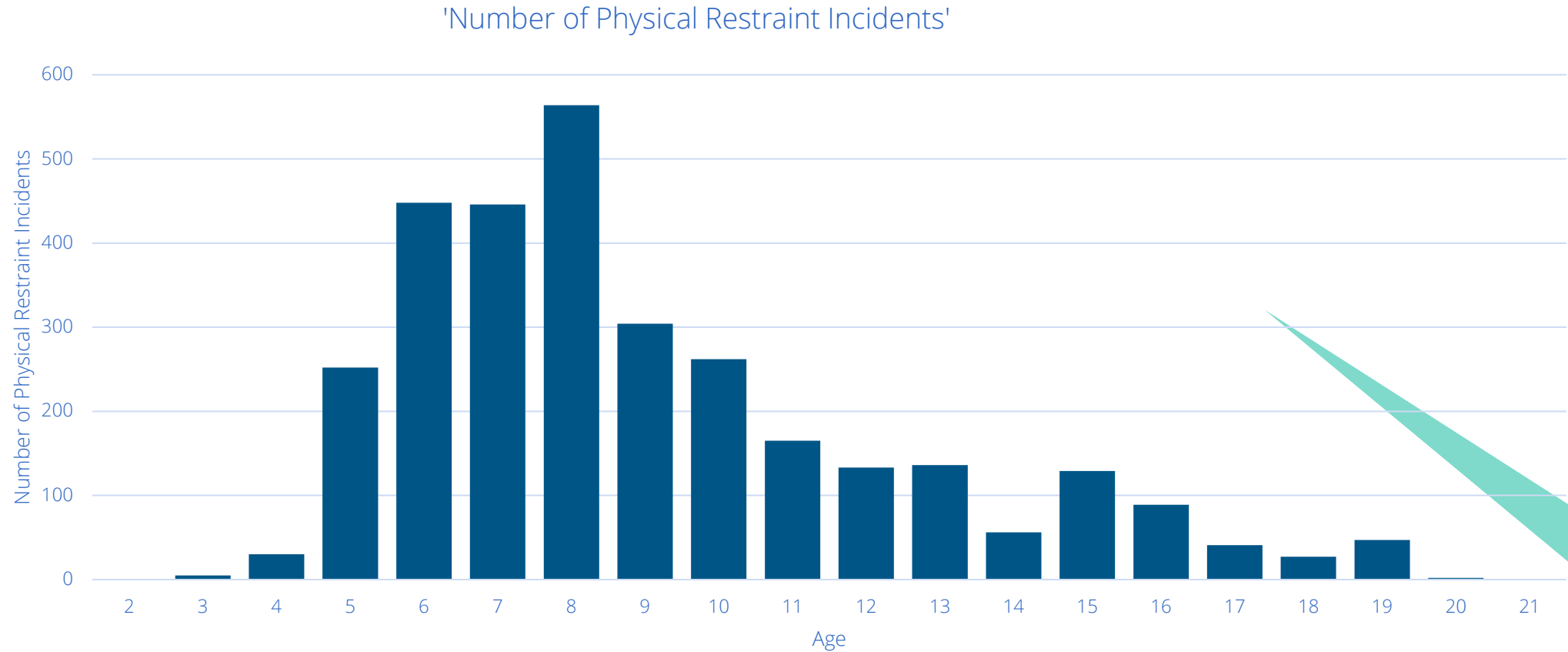

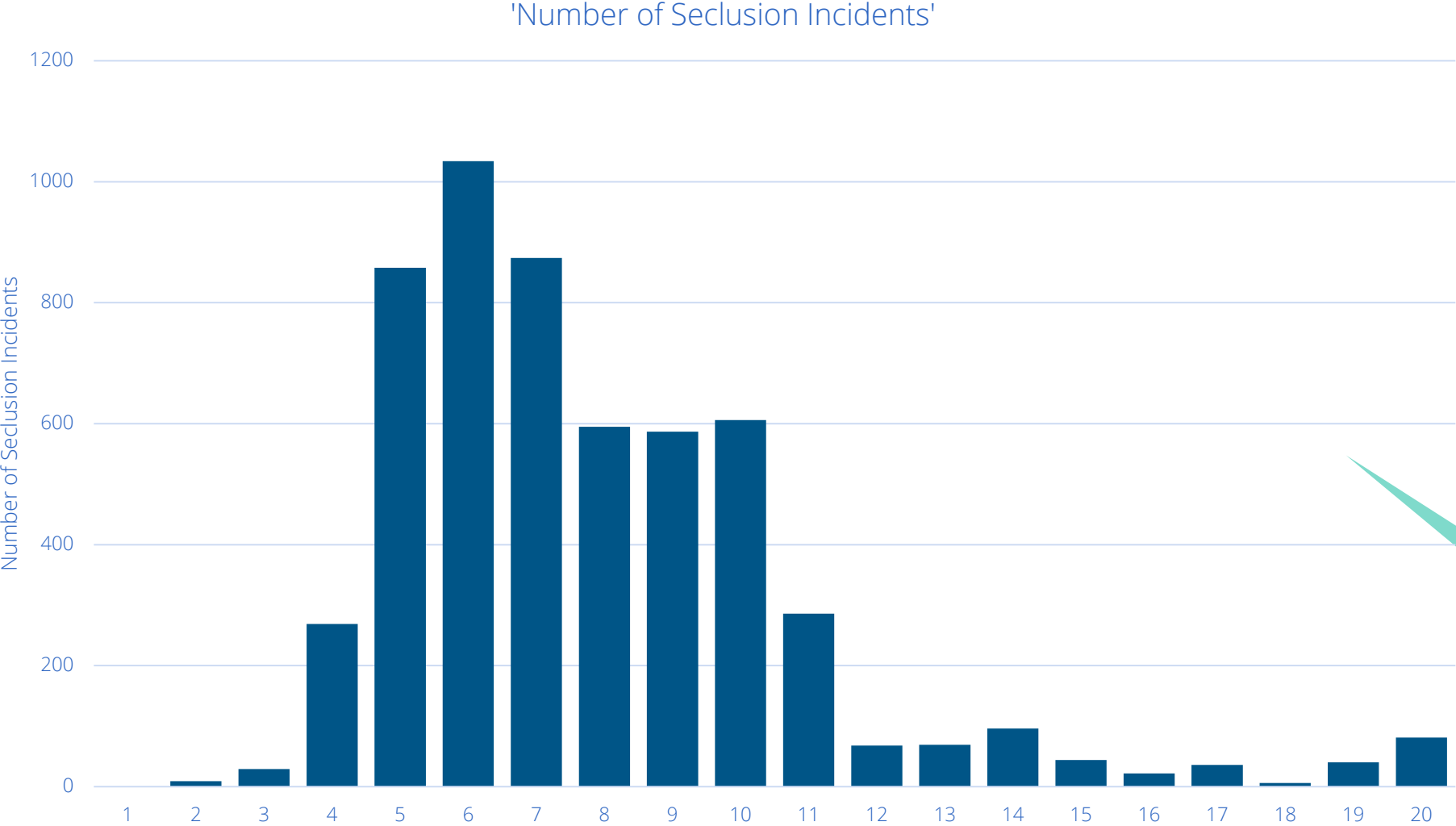
'Number of Physical Restraint Incidents', 'Number of Seclusion Incidents', 'Number of Emergency Safety Intervention Incidents' by 'Age'

Indicator 12: Part C to Part B Transition

Part C to Part B Electronic Referral System (CBER)

- Make sure your agency is regularly logging into the CBEP system to review and accept/reject referrals.
 - KSDE is required by the Office of Special Education Programs (OSEP) to maintain a statewide system that tracks children who are transitioning from Part C to Part B.
 - The CBEP system allows for confirmation of the accuracy of referral dates reported by both C and B programs.
 - The transition timeline for a referral **begins** on the date it is sent by Part C unless the referral is actively rejected by Part B. The only reason a school district can reject a Part C referral is if the child did not live in the district of residence at the time of the referral.

Who is considered LEA representative for Part C Transition Conferences?

- The representative of Part B who attends the transition conference should be a person who is knowledgeable about the Part B preschool special education program, evaluation & eligibility processes, and the availability of services. The LEA representative should also be able to provide information about Part B program options, as appropriate, to inform parents in their decision making, and be able to answer questions from the family as they arise. Part B personnel can be but is not limited to:
 - School psychologist
 - Early childhood special education teacher
 - Related service providers
 - Sped director
 - Early childhood director

Indicator 6: Preschool Environments (Updates)

Our state picture

- **2023-2024: 110 districts met state targets for Indicator 6**
 - Statewide rate for Indicator **6A: 47.42%** (higher is better)
 - Statewide rate for Indicator **6B: 30.00%** (lower is better)
- **2024-2025: 114 districts met state targets for Indicator 6**
 - Statewide rate for Indicator **6A: 49.74%** (higher is better)
 - Statewide rate for Indicator **6B: 26.89%** (lower is better)

Outcomes Part B Web System (OWS)

Please make sure to

- Conduct regular checks and update the OWS system as students enter and exit the district
- Complete COS forms for students qualifying for special education services, including students that qualify for speech only



OWS Tips & Reminders

- If students leave your district but attend another district in Kansas, that is an **organizational exit**
- If students enter your district but previously attended another district in Kansas, that is an **organizational entry**
- Students that withdraws, move out of state or parents revoke SPED services needs to be **permanently exit**

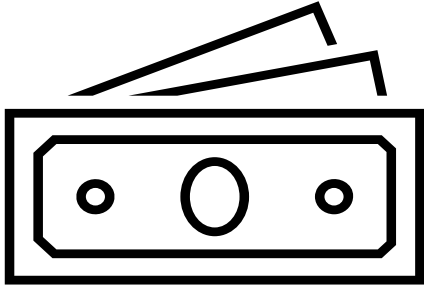

November 14 to January 14 - Reporting collection window

- November 14 – Submission window opens
- December 15 - Submission deadline for coop/interlocal member districts
- January 14 - Submission window closes for stand alone, coop/interlocal LEAs



Why Is MOE Required?



MOE is required to ensure that LEAs do not replace state/local funding with federal funds.

What Does MOE Mean?

LEA MOE means that each year for the education of children with disabilities, an LEA:

Budgets at least as much as it expended in the most recent year it met MOE. (**Eligibility**)

Expends at least as much as it expended in the most recent year it met MOE. (**Compliance**)



Excess Cost Report

- IDEA funds may only be used to pay the excess costs of providing special education and related services for children with disabilities.
- The Excess Cost Report calculates the minimum amount of state and local funds that an LEA must expend for the education of students with disabilities before accessing VI-B funds.
 - Excess cost is computed separately for elementary and secondary students

- SSIDs are now available in KIAS
 - Answer yes/no for the question(s) the district had continued non-compliance on.
 - Upload documentation showing the question is compliant.
 - Make sure to hit submit when finished

- Window Oct. 10-23



Cohort 2 - Compliance Verification

10/11-10/25

- Districts that self-reported non-compliance.
 - Districts may upload any documentation they have found to show compliance – this does not include corrections for non-compliance.
 - KSDE will review any documentation already submitted once you click submit in the compliance verification tab.
- Random districts – check KSDE comment on KIAS, there may be additional information suggested to upload for potential compliance.
- All districts in compliance verification need to submit even if you have no documents to upload.

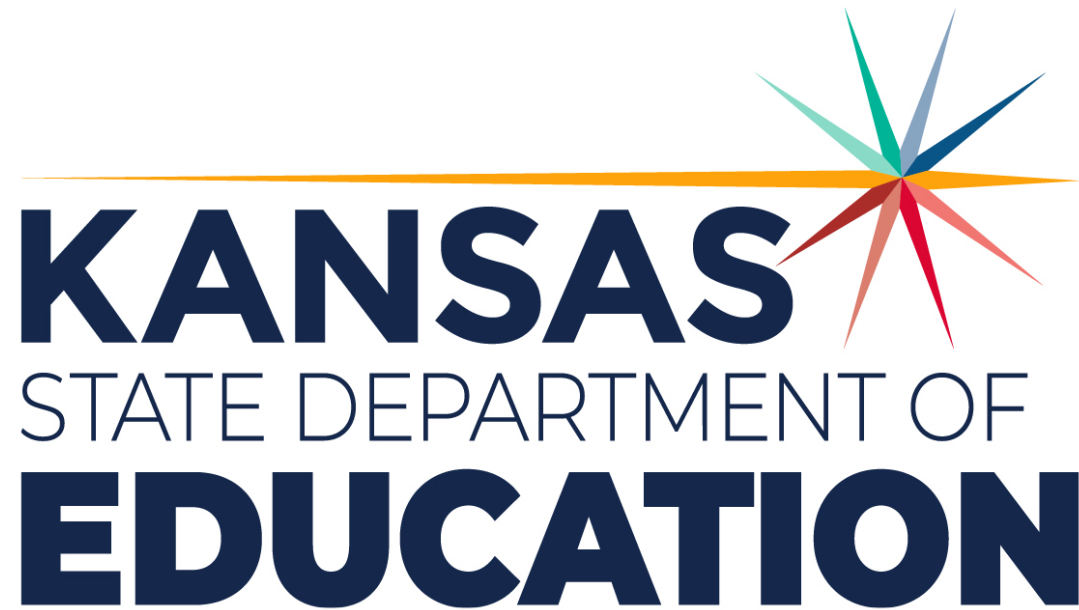


Next steps

- Compliance Letters – October 31
 - Non-compliant districts
 - **DCAP** for each question that had non-compliance (Nov. 3-Dec. 2).
 - **ICA** for each student that had non-compliance. Students with more than one question with non-compliance will need an ICA for each question. (Nov. 3 -April 1). Students who have graduated or are no longer in the district do not need an ICA. Click the red x on the far-right side of screen and indicate reason.
 - **Updated data** – Districts answer yes/no for each non-compliant question for selected files with IEPs completed between March 5, 2026 - May 29, 2026.
 - KIAS will pull files completed between 3/1/26 -5/1/26.
