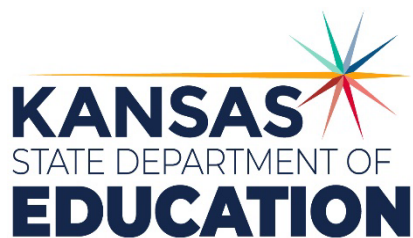

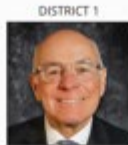

Glossary

Term	Meaning
Area	The total area enclosed within the boundaries of the USD in square miles.
Index of Density	The number of pupils who, on September 20 of the current school year, are residing in the district and 2.5 miles or more by the usually traveled road from the schoolhouse they attend and for whom transportation is being made available on regular routes by the district, divided by the number of square miles of territory in the district.

Pupils Transported

The table below provides a history of the total number of pupils transported by public school districts for regular routes. To be eligible for funding, students must be present on count day¹, reside in the district and live 2.5 miles or more from their attendance center.

We measure the number of miles by taking the normal route from the pupil's home address to their attendance building.
