Structured Literacy

We provide literacy instruction in pre-K-12 aligned to the science of reading and assure teachers and admin are well-trained and knowledgeable in the elements and implementation of structured literacy.

Standards Alignment

We align lessons, instruction, and materials to Kansas standards and clearly identify what students must know and be able to do. This includes interpersonal, intrapersonal, and cognitive skills in pre-K-12.

Balanced Assessment

We assess students for risk and standards and use data to adjust instruction. We have a deep understanding of the purpose of each assessment and how to use the data to raise achievement.

Quality Instruction

We have a culture of high expectations in our classrooms and provide each student access to grade level standards and content though high-quality instructional materials.

Analyzes information and presents to the Accreditation Review Council (ARC) when a system is not meeting a standard.

Reviews compliance issues, information and data from KSDE. Makes recommendation to the State Board.

Determines accreditation.

KESA Action Plan Implementation

Each system will be evaluated using the following standards:

- Standard 1 Plan (Ready to Implement Action Plan)
- *Standard 2 Do
- *Standard 3 Study
- *Standard 4 Act







Standard 1: Plan



The System develops a clear, data-informed action plan that is aligned to the School Improvement Model, describing the specific actions to enhance the Fundamentals by building upon coherent actions.

Standard 2: Do



The System implements the action plan through clear steps, monitors progress, identifies barriers and communicates with key stakeholders.

Standard 3: Study



The System collects, analyzes and applies data to monitor the implementation and impact of the action plan on professional action.

*In the future, student data will become part of this standard.

Standard 4: Act



The System utilizes data to refine strategies, identify and sustain effective practices and plan for future actions.

KESA Graduation Rate



- The KESA Graduation Rate is based on the 5 most recent graduation rates.
- Calculated by taking the total number of graduates from the 5 most recent graduating classes and dividing by total number of students in the 4-year cohort in each of those classes.

Ex. – State KESA Graduation rate

Graduating classes of 2020, 2021, 2022, 2023, 2024

Total number of graduates – 169, 657

Total number in 4-year cohorts – 191, 396

State KESA Graduation rate: 169, 657 / 191, 396 = **88.7%**

KESA Graduation Rate of Change

- The KESA Graduation Rate of Change is the difference between the KESA Graduation Rate from one year to the following year.
- Calculated by subtracting the most recent KESA Graduation Rate with the KESA Graduation Rate from the previous year

Ex. – District A

KESA Graduation Rate (2020-2024) - 96.2%

KESA Graduation Rate (2019-2023) - 96.5%

KESA Graduation Rate of Change: 96.2 - 96.5 = -0.3%

KESA Graduation Standards – Significant numbers

Targets

- **95%** State Goal
- 88% The state KESA graduation rate has recently ranged between 88-89%.
- Rate of Change from One KESA Cohort to the Next
 - 2% Rounded to a whole number from -1.60; the average rate of change for systems whose KESA Graduation Rate decreased between 2023 and 2024

- This district typically has 1 non-graduate each year.
- In efforts to continually improve graduation rates and keep low non-graduate counts, the system has met the 95% threshold for exceeds performance expectations for two consecutive years.

- While the system had relatively high single year graduation rates in the past, recent graduation rates have lowered which has caused the KESA graduation rate to decline from the previous cohort for the past four years.
- Cohort sizes have increased in the system. However, the percent of graduates have not met the rate at which the cohort size has increased.
- The system has been flagged as "identified need" for the past four years. If this trend continues, the system will require an on-site review from the ARC.

- This district has consistently had KESA graduation rates around 71%.
- Because the system has experienced decreases or stagnant rates from one cohort the next, they were
 previously flagged as "identified need."
- The system must demonstrate improvement from one cohort to the next to continue to meet performance expectations.

October 2027	Systems submit DGSR for 2027		
January 2028	 Each system's KESA Graduation Rate (2023 through 2027) is evaluated against the standard, including comparing the current KESA Graduation Rate (2023-2027) to the previous year's KESA Graduation Rate (2022-2026) 1. Systems notified of Meet/Does not meet standard. 2. Identified Need systems will address this outcome in their Action Plan. 		

Year 2 Evaluation Timeline				
October 2028	Systems submit DGSR for 2028			
January 2029	 Each system's KESA Graduation Rate (2024-2028) is evaluated against the standard, including comparing the current (2024-2028) to the previous year's KESA Graduation Rate (2023-2027) 1. Systems notified of Meet/Does not meet standard. 2. Systems that have been in Identified Need 2 years in a row will be referred to the ARC. 			
February – May 2029	ARC On-site Review with systems to provide support and feedback			
June 2029	The ARC votes on the System's accreditation status based on the what was learned at the On-site Review. Recommendation could be to remain accredited or be accredited with conditions.			
July 2029	ARC recommendation of accreditation to the State BOE followed by action by State BOE

2024-2025 KESA Compliance

- On May 15th of each year, KSDE will take a snapshot of each system's Compliance status in each of the KESA Compliance areas.
- If a system is **not in compliance** in any one area as of May 15th, the Superintendent will be notified soon after May 15th via email.
- Any system that is **not in compliance** as of July 1 will be notified of its non-compliance and that being "not in compliance" as of next July 1 (2026), will prompt an ARC review.

Coming soon, compliance status will be available in the KESA application.
