Title I, Part A Submission Requirements



Overview

In accordance with the Every Student Succeeds Act (ESSA) of 2015, every Title I, Part A Schoolwide and Targeted Assistance Program is required to meet specific statutory requirements. In order to help districts meet these requirements, KSDE utilizes the KansaStar platform to allow Kansas public school buildings to submit their schoolwide action plan, their targeted assistance plan, and other required documentation for review and approval.

This document serves as a checklist for all required documents that must be submitted to ensure compliance.

Responsibilities

Building Level

- Submit (upload) necessary Title IA documentation into the KansaStar platform for each checklist item noted below. Submission Deadlines:
 - o Documents & Plans must be uploaded and reviewed/approved by the district on or before November 26th, 2025.
 - Districts will provide guidance to their Title I schools for their building submission due dates.
 - Schoolwide Action Plan due date: date schools must upload the Targeted Assistance plan for review and approval
 - Targeted Assistance Plan due date: date schools must upload the Targeted Assistance plan for review

District Level

- Provide guidance to their Title I schools for their building submission due dates and ensure that each school meets documentation requirements by stated deadlines.
- Review and approve schoolwide action/improvement plans on or before November 26th, 2025.

Appendix

Parents' Right to Know Letter

This letter is issued to parents to notify them that they may request information regarding the professional qualifications of their student's classroom teachers and request access to their student's state assessment scores.

Also included in this letter, schools must inform parents that they will receive notification when their student is instructed for four continuous weeks by a teacher that does not meet state certification for grade level and content are taught, and to inform them of and provide access to the district/state report cards.

Letter to parents and community to inform them how to access district/state report card information

This letter is issued to parents and community members to inform them of and provide access to the district/state report cards. Examples include – Newspaper/newsletter or district/school website posting.

Letter to parents when students are instructed for four continuous weeks by a teacher that does not meet state certification.

This letter is issued to parents to notify them that their student is instructed for four continuous weeks by a teacher that does not meet state certification for grade level and content are taught. Each district/building must have a letter on file that will be sent should the situation arise.

Parent School Compact

The compact addresses the importance of communication between school and home. Signatures are the easiest way to demonstrate compliance; however, it should be noted that a signature is an acknowledgement of receiving the information and is not a federal requirement.

Targeted Assistance Plan

This plan must outline how the school will implement the required components of a Title I Targeted Assistance program to assist eligible participating children to meet the challenging state academic standards.

Schoolwide Plan

This plan must outline how the school will implement the required components of a Title I Schoolwide program to ensure that all students are provided with opportunities to meet the challenging state academic standards.
