SFY24 TITLE IVA OUTCOMES REPORTING

Purpose

Each State that receives an allotment under Title IV, Part A (ESEA §4103) for a fiscal year shall report on how funds made available under this part are being expended by Local Education Agencies (LEAs), including the degree to which the LEAs have made progress toward meeting the objectives and outcomes of their activities to provide their students with support programs allowable under the Title IVA program.

- 1) **Well-Rounded Education (Section 4107)** – Access to, and opportunities for a well-rounded education for all students.
- 2) **Safe and Healthy Students (Section 4108)** – Improve school conditions for student learning in order to create a healthy and safe environment.
- 3) **Support the Effective Use of Technology (Section 4109)** – Improve the use of technology in order to improve the academic achievement and digital literacy of all students.
